CITY OF ELBERTON FINAL MEETING OF THE 2019 MAYOR AND COUNCIL

Monday, January 6, 2020 – 5:30 p.m.

Pursuant to due call and notice thereof the meeting of the Mayor and Council convened at 5:30 p. m. on Monday, January 6, 2020 in Council Chambers of the Municipal Building, 203 Elbert Street with Mayor Guest presiding.

Present were: Council Members Butler, Colquitt, Hunt, Parham and Prince; City Attorney Jenkins, City Manager Dunn and City Clerk Churney.

Mayor Guest called the meeting to order and led the assembly in the Pledge of Allegiance. Rev. Gary Purvis let the assembly in prayer.

Council Member Butler motioned to approve the minutes of the December 2 meeting, seconded by Council Member Parham and the motion passed unanimously (Butler, Colquitt, Hunt, Parham, Prince).

There were no speakers from the floor or Ordinances and Resolutions to be considered at this meeting.

Council Member Butler motioned to approve the consent agenda, seconded by Council Member Hunt and the motion passed unanimously (Butler, Colquitt, Hunt, Parham, Prince).

CITY CLERK:

The department is working to update Elberton's boundaries as part of the LUCA update for the 2020 census.

Over 300 items were delivered to East Central Regional Hospital in Augusta on behalf of the employees for the Annual Mayors' Christmas Motorcade.

The department mailed 453 business license renewal applications for calendar year 2020, which included renewals for occupational, regulatory, financial, vending/amusement, and professional tax licensing. Businesses have until April 1 to submit renewals.

Five Secondhand Dealer renewal applications were mailed for calendar year 2020.

Four non-profit peddler's permits and three for-profit peddler's permits were issued during calendar year 2019.

HUMAN RESOURCES:

The department will be participating in the Job Fair at the Elbert County Comprehensive High School next month along with a dozen other local businesses.

FIRE DEPARTMENT:

The Fire Department responded to 55 alarm calls for the month of December 2019. These calls consisted of 3 Vehicle Accidents, 37 Medical Emergencies, 9 False Alarms, 1 Structure Fire (Contained to Floor Furnace), 1 Power Line Down, 1 Assist to Police Department, 1 Flammable Liquid Spill, and 2 Aircraft Standby. The department conducted 4 fire inspections, and issued 2 burn permits. The Fire Department also conducted 285 hours of in-house training and 0 out of station training for the month as well.

BUILDING INSPECTOR:

The building inspection department issued 16 permits for the Month of December, 2019. The department issued 6 Building Permits, 5 Electrical Permits, 2 Plumbing permits, 2 Sign Permits, and 1 Driveway permit. During this same period there were 8 Building Inspections, 7 Electrical Inspections, 1 Driveway Inspection, and 3 Sign Inspections.

POLICE DEPARTMENT:

Officers from the police department hosted this year's "Shop with a Cop" program at Wal-mart as we have done in years past. Twenty-one children who were not expecting a very prosperous Christmas were treated to a \$100 gift card that they could use to purchase gifts for themselves and their family. Each child shopped with an officer until they got everything they wanted. This year's program was a great success thanks to the officers, Elbert County school system, the children and of course the Wal-mart Corporation.

The Elberton Police Department released their monthly activity for the month of November 2019. The department recorded:

- 1145 Calls for Service
- 347 Vehicle Traffic Stops
- 132 Incident Reports were filed
- 268 City Court cases made
- 28 Traffic accidents were investigated

- 87 People were arrested for various charges
- 26 Person was arrested for Driving under the Influence
- 34 Drug related charges were made
- 108 Department Training Hours

WATER & SEWER:

The crews repaired water leaks on Roosevelt Street, Park Street, Porter Drive, South Oliver Street and Seaboard Street. The crews replace a fire hydrant at the corner of North Oliver Street and Deadwyler Street. The crews repaired a fire hydrant on Tate Street. The crews raised valve boxes along Elbert Street and Tate Street to the new asphalt level. The crews installed a 3/4 inch water tap and meter at 2581 Athens Highway. The crews set valve boxes at the intersection of Sam Paul Road and Athens Highway.

The crews cleaned and inspected sewer services on South McIntosh Street. The crews made repairs to Industrial Park, Hickory Drive and Silk Mill lift stations. The crews replaced the drive roller gears and bearings on the Fortson's Creek Wastewater Plant belt press. The crews repaired leaks on both the chlorine and caustic feed systems at the Filter Plant. *ELECTRIC:*

The electric department installed a new underground service on Filter Plant Drive. The department pulled 19 old poles from transfer tickets that had been completed by AT&T. Some tickets were 6 years old. The department installed 6 new security lights for Pilgrims.

CITY MARSHAL:

In collaboration with the GA Dept of Revenue Alcohol & Tobacco Division we conducted an underage undercover alcohol sales investigation. Of the 29 businesses that have an alcohol license, 20 businesses that were open were checked. We had zero (0) violations for alcohol sales. The businesses did a great job of asking for proper ID prior to the sale of the alcoholic beverage to the minor.

PUBLIC WORKS:

The TSPLOST paving project phase 1 is complete. The project included Progress Boulevard, Park Street, Woodland Rd., McKinley, Willow, Thompson, Cole, Bartlett, and Tate Streets.

NATURAL GAS:

The Natural Gas Department activated the 4" High Density pipe line from Sam Paul Rd at Athens Hwy to the dead end of existing 2" PE on Nickville Rd. The department also bored underneath Bowman Hwy with help from the Electric Department. The purpose of the bore is to installing two new 2" regulator stations to expand capacity. One will feed Nickville Rd. and the other will feed Pulliam Mill Rd. to fix both pressure issues that have been occurring during periods of high consumption.

The department installed two residential services and removed one for demolition. The department completed our normal tasks including Routine Patrolling, CP Test Points and Rectifier to finish out the maintenance for the year to meet all compliance requirements.

MAIN STREET:

We kicked off our 12 Days of Christmas Cash on November 15, highlighting different merchants each day of the event. Candle Light Shop Night was held on Tuesday, Nov. 26 downtown on the square. We had the lighting of the Christmas tree, Snow on The Square, Santa, vendors, Christmas Carolers, L3 Baton performed, and downtown merchants and restaurants stayed open later for the event. We also had several activities for the kids that included fire truck rides, face painting, Christmas crafts, community coloring banner, outdoor Christmas movie, along with popcorn and hot chocolate. Everyone turned in their receipts from the 12 Days of Christmas Cash and a winner was drawn for the \$500 cash prize and 5 additional winners were drawn for the \$100 in Downtown Dollars. We had a record breaking 1,119 tickets turned in for the drawing. That was a total of \$11,190.00 in sales in the downtown business area that was generated during the 12 Days of Christmas Cash. We have received much positive feedback from this year's event.

The annual Christmas parade was held on Sunday, December 1 at 4 p.m.

The DDA/Main Street board held their yearly planning session on the evening of Tuesday, December 10 at City Hall. Plans for the 2020 New Year were discussed and strategies on how to execute these plans were laid out. The 2020 event calendar was also set and approved. We look forward to growing these events and the amount of people each will bring in.

ELBERT THEATRE:

There were 46 events including ETF's Christmas Movie Field Trips & paint classes; COE's *Frozen II & Star Wars: The Rise of Skywalker* movie showings, Encore Productions' *Elf Jr* rehearsals, performances and cast party & *Hank Williams* auditions and rehearsals; and DAR's *Nancy Hart* film screening at the Elbert Theatre & Arts Center from Nov 20-Dec 23.

A total of 3,997 patrons visited the Elbert Theatre & Elberton Arts Center between November 20 and December 23.
