## CITY OF ELBERTON REGULAR MEETING OF THE MAYOR AND COUNCIL Monday, March 4, 2019 – 5:30 p.m.

Pursuant to due call and notice thereof the meeting of the Mayor and Council convened at 5:30 p. m. on Monday, March 4, 2019 in Council Chambers of the Municipal Building, 203 Elbert Street with Mayor Guest presiding.

Present were: Council Members Butler, Colquitt, Hunt, Parham, and Prince; City Attorney Jenkins, City Manager Dunn and City Clerk Churney.

Mayor Guest called the meeting to order, led the assembly in the Pledge of Allegiance and prayer.

Council Member Butler motioned to approve the minutes of the February 4<sup>th</sup> meeting, seconded by Council Member Hunt and the motion passed unanimously (Butler, Colquitt, Hunt, Prince, Parham).

Mr. Freddie Baker spoke to Council on behalf of the Concerned Men of Elbert County who are located in the City of Elberton's Burke Street building at 130 Burke Street.
