CITY OF ELBERTON FINAL MEETING OF THE 2021 MAYOR AND COUNCIL

Monday, January 3, 2022 – 5:30 p.m.

Pursuant to due call and notice thereof the meeting of the Mayor and Council convened at 5:30 p. m. on Monday, January 3, 2022 in Council Chambers of the Municipal Building, 203 Elbert Street with Mayor Guest presiding.

Present were: Council Members Butler, Colquitt, Burton, Parham and Prince; City Attorney Jenkins, City Manager Dunn and City Clerk Churney.

Mayor Guest called the meeting to order and led the assembly in the Pledge of Allegiance. City Attorney Jenkins led the assembly in prayer.

Council Member Butler motioned to approve the minutes of the December 6 meeting, seconded by Council Member Burton and the motion passed unanimously (Butler, Colquitt, Burton, Parham, Prince).

There were no speakers from the floor or Ordinances and Resolutions to be considered at this meeting.

Council Member Parham motioned to approve the consent agenda, seconded by Council Member Prince and the motion passed unanimously (Butler, Colquitt, Burton, Parham, Prince).

- 1. Authorized the issuance of an alcoholic beverage license to Bhargavkumar (Bob) Shah for retail of beer and wine license for Petro Food Mart located at 310 Elbert Street.
- 2. Authorized the issuance of an alcoholic beverage license to Richard Melton on behalf of the Elberton Country Club for on premises consumption of beer, wine and distilled spirits license
- 3. Authorized the closing of various streets on Sunday, January 16, 2022 for the Annual Martin Luther King Parade sponsored by the Martin Luther King Parade Committee.
- 4. Accepted the minutes, decisions and recommendations of the December 27, 2021 Elberton Planning Commission Meeting.

City Manager Dunn presented the following reports:

CITY CLERK:

The department issued the following licenses and permits over the past five years:

After a final public hearing held in December, the 2022 Comprehensive Plan update was submitted to the Georgia Department of Community Affairs for a compliance review. Upon approval, the plan will need to be adopted by the Mayor and Council as required by Georgia Planning Act of 1989.

Pursuant to House Bill 879, the Georgia Department of Revenue is updating its alcohol licensing to develop a centralized alcohol licensing portal in partnership with local licensing agencies and license holders. The portal is intended to be a platform where both local and state alcohol license applications are submitted in order to streamline the licensing process and eliminate redundant processing. Phase 1 of this process will take effect in January of 2022.

FIRE DEPARTMENT:

The Fire Department responded to 54 Alarm Calls for the month of December, 2021. These calls consisted of 9 Vehicle Accidents, 35 Medical Emergencies, 5 False Alarms, 3 Aircraft Standbys, 1 Vehicle Fire, and 1 Structure Fire, The department conducted 6 fire inspections, 3 Pre Plans, and issued 3 burn permits. The Department conducted 326 hours of in-house training.

BUILDING INSPECTOR:

The building inspection department issued 8 permits for the month of December, 2021. Permits issued: 3 Electrical permits, 3 Building permits and 2 Sign permits. During this same period there were 6 building inspections, 4 electrical inspections and 2 sign inspections along with 5 site visits.

POLICE DEPARTMENT:

The Elberton Police Department released their monthly activity for the month of November 2021. The department recorded:

- 1,064 Calls for Service
 - 530 Vehicle Traffic Stops
 - 67 Incident Reports were filed
 - 284 City Court cases made
 - 18 Traffic accidents were investigated
 - 42 People were arrested for various charges
 - 9 Person was arrested for Driving under the Influence
 - 186 Department Training Hours

WATER & SEWER:

The crews repaired water leaks on Fairway Drive, Burke Street, Medical Drive, Elbert Street, Mineral Springs Road and Brookwood Circle. The crews installed water taps at 1037 Old Middleton Road, 1469 Lena Drive and 1171 Russell Ridge Court. The crews cleaned and inspected sewer mains on Evergreen Drive and Country Manor Lane. The crews cleaned and inspected sewer laterals on Wayne Street, Pulliam Street and Almond Street. The crews installed sewer taps at 1037 Old Middleton Road and 307 South McIntosh Street.

Construction continues at the Filter Plant on the new clearwell and high service pump station. The contractors made the first wall pour of concrete on Thursday, December 23, 2021.

ELECTRIC:

The Electric Department replaced an old poles on N. McIntosh St. and on Old Hartwell Road. The

department removed a dead tree on Pulliam Street for the Street Department. The department replaced 10 poles and 4 transformers at Turner Concrete due to age.

PUBLIC WORKS:

The department performed routine maintenance and operations during the month of December. The Street Department installed new shorter, rubber, and more visible parking bumpers from the Samuel Elbert Hotel down to Papas Pizza on the square in place of the taller concrete ones that were there.

NATURAL GAS:

The Natural Gas Department installed a 2" High Density Main on Press Mann Rd. to serve a new customer building a new house.
