I further understand that “any person acquiring an animal from a public or private animal shelter, animal control agency operated by a political subdivision of this state, humane society, or public or private animal refuge, which animal is not sterile at the time of acquisition, shall submit to the animal shelter, animal control agency, humane society, or public or private animal refuge, a signed statement from the licensed veterinarian performing the sterilization required by paragraph (2) subsection (a) of this Code section within seven days after such sterilization has been performed.”
